BUS TRANSPORTATION AND SAFETY

Proper student conduct on the bus is important for bus safety. Bus drivers cannot perform their duties properly and safely drive the bus if their attention is drawn to the students on the bus. The driver has the authority regarding discipline on the bus and the students must realize that they are to follow the directions of the bus driver in order to maintain their bus riding privileges. Each student must share in the responsibility of maintaining safety on the bus. Remember, riding the bus is a privilege, not a right.

School bus drivers, in cooperation with the school district and the bus company, established the rules for a safe and orderly bus ride. At the beginning of the year and periodically throughout the year, these rules will be reviewed and discussed.

Students are expected to be at the pickup location at least five minutes prior to their assigned pickup time. The school bus driver will not wait for students, nor will the driver be sent back to pick up late students that miss the bus.

As the parent/guardian, I have read the Student Transportation Expectations and Consequences for Inappropriate Behavior found on Page 25 of the Student Handbook. My child and I have discussed this letter, the bus safety expectations, and consequences. We understand that failure to follow these expectations may result in the loss of riding the school bus.
